DISTRICT CONSULTATION

SPP Indicator 12

Dr. Mickelson reported that all districts were found to be compliant on SPP Indicator 12 of the State Performance Plan: "Percent of children referred by Part C prior to age 3, who are found eligible for Part B, and who have an IEP developed and implemented by their third birthdays."

MOE

Data submitted to KSDE has indicated that TLEC is compliant in two of the potential four test areas regarding Maintenance of Effort. Only one of the four tests needs to be met in order to be in compliance.

March BOD/SAC Meeting Date

Drivers Education not ESY

Summer drivers education is not considered part of the extended school year and is therefore not eligible for categorical aid reimbursement. However, paraeducator support can still be arranged to assist students, if needed. Districts have agreed to reimburse TLEC for paraeducator support for summer drivers education programs. Paraeducator support for drivers education during the school year hasn't changed at this time.

Six Member District Inservice

The option of all districts participating in a joint October inservice was discussed with the superintendents. The consensus was that they would prefer individual inservice activities at this time.

Calendars

Districts were asked to submit a copy of their 2014-15 calendar to TLEC as it became available.
