Approval of Agenda

DISTRICT CONSULTATION

Region J Kansas Multi-Hazard, Multi-Jurisdictional Hazard Mitigation Plan - Approval

Following reading, motion was made by Lynda Farwell and seconded by Cindy Cook to approve the Region J Kansas Multi-Hazard, Multi-Jurisdictional Hazard Mitigation Plan. Motion passed 5-0.

Passage of this plan will allow TLEC to access federal funds for mitigation projects if funds become available.

Indicator 11: Initial Evaluation - Informational

Five of our six districts were found to be compliant on SPP Indicator 11: Initial Evaluation. The regulatory requirement of Indicator 11 is that children must be evaluated within 60 days of receiving parental consent for the initial evaluation. Dr. Mickelson explained the issue that lead to non-compliance in one district and noted that a plan of action will be written to address this issue.

MDCV Blue Ribbon School Award - Informational

Dr. Mickelson extended congratulations to MDCV Elementary School for receiving the designation as a 2014 National Blue Ribbon School from the U.S. Department of Education.

Superintendent/Board Member Discussion Items

SPED Funding

Information regarding the cost to educate a special education student compared with the cost to educate a general education student was shared. According to information obtained from KSDE, special education student cost is estimated at \$31,164 per student annually while general education cost per student is \$12,960 annually.

 ESI Letter to Kansas Board of Education and Board Contact Information

Dr. Mickelson reviewed a letter from Terry Collins, Director of SPED at Doniphan County SPED Coop to Deena Horst, District 6 Kansas State Board of Education board member detailing some of the concerns of KASEA members regarding Emergency Safety Intervention regulations. A list of names and addresses of Kansas State Board of Education members was also included.

Insurance

As the ACA stands now, TLEC will need to have health insurance options for paraeducators in place by October 1, 2015. TLEC is currently exploring plan options with BCBS. David Shriver, Director of Insurance Services and staff attorney with KASB, has asked to present Coventry health insurance options to the board at the December meeting.

Flow Thru

The impact of decreased flow thru and federal funds for TLEC as well as, dwindling cash reserves for the districts was discussed among the superintendents at their meeting Friday.

Kansas Reading Road Map

Dr. Pegram shared information about this program with his colleagues on Friday.

Matters Relating to Student Issues - Executive Session

Certified Evaluations – Phase 1 Extended Unpaid Leave
