VOCAL MUISC



LASTMEETING

The April 8 meeting was at Santa Fe Trail High School. It was a combined meeting with the Sawdusters Club and we had 31 members in attendance. Vaughn Graber reported \$1,670 in the treasury.

ShowandTell

Jim Beck brought a miniature vase (3/16" d x 1" h), a "Christmas Ornament" and a shop-made hollowing tool utilizing an Allen wrench.



Bruce Bower showed two cremation urns for pets (5" d x 5" h and 5" d x 8" h) both of maple. The larger urn had a dog's paw print in the side. He also showed a shallow burl platter.

Bob Rouser had turned two pens and a letter opener from some black walnut burl from Merle Shogren's estate. He and Don Bergeson offered pieces of the burl to members of the club.

Darrel Kellerman showed square bowl (12 3/8" sq. x 1 3/4" h), textured with a three-tooth rotary tool and then ebonized with black milk paint and lightly sanded to show some of the wood. He learned this technique from a class with Al Stirt at Arrowmont. Darrel will demonstrate this project at the May meeting.

Rusty Smith brought one of the oval-shaped vases he demonstrated at the February meeting (2 $\frac{3}{4}$ " d x 6 $\frac{1}{4}$ " h). The shape is turned using two different center points while spindle turning the outside shape.



Demonstration

Terry Stanton, Industrial Education Instructor at Santa Fe Trail, demonstrated several jigs he had made for the table saw:

- Y A jig for cutting coves in trim. It guides the stock across the saw blade at an angle to cut a uniformly shaped cove. He recommended a 1/16" depth of cut for each pass.
- Y A tapering jig. Two boards were fastened together at one end with a hinge and the other end had a pivoting board to hold the ends apart the necessary distance to get the desired taper on the stock as it is angled away from the rip fence.
- Y A jig for cross-cutting multiple, narrow pieces to length at the same time. The jig consisted of a sheet of plywood with

- a fence at the right side to hold the stock even and a fence at the rear to hold the stock perpendicular to the blade. The jig butts against the rip fence and the cut-off pieces fall to the table as they are cut off.
- Y A jig for making square stock into a cylinder. The jig fits into both grooves in the saw table and slides forward and back. The stock is supported by a pointed bolt at the front and by a drive point held in an electric drill at the back. The drill rotates the stock as it is fed back and forth across the saw blade. A depth of cut of 1/16" was recommended.
- Y A jig for cutting multiple coves across the face of a board. This process results in a wavy surface on the stock.

SPECIAL JOINT SESSIONS AT AAW SYMPOSIUM This year, the AAW and The Furniture Society (FS) have partnered to present registered Symposium attendees with a series of joint sessions, entitled "Fresh Eyes no Furniture: Tradition and Innovation," scheduled for June 23 and 24. These bonus sessions will include both demonstrations and panel discussions on furniture-related topics from inlay and embellishment, to cold metal casting and computer controlled routing, as well as how the disciplines of furniture making and woodturning intersect. Featured presenters include Scott Grove, Bart Niswonger, Mark Sfirri, and Kimberly Winkle. All four have extensive education and training in furniture design and construction:

Scott Grove- Scott is a third-generation artist who designs and creates furniture, sculpture and other work to engage the senses. His work has won numerous awards and is in the permanent collections of museums and galleries. Scott has authored several books and writes for a variety of publications. He is a graduate of Rochester Institute of Technology and a featured instructor of design and furniture making schools.

<u>Information from KSHSAA concerning physical and concussion forms is below.</u>

As you are making preparations for the 2017-2018 school year, please be reminded both the Pre-Participation Physical Exam AND the updated Parent/Student Concussion Information Release forms are available for download on the KSHSAA website. Both of these annual forms are required to be on file at the school for every student-athlete and cheerleader, prior to participation in a first practice.

The most current PPE form has a revision date in the lower right hand corner of 1/15 and can be accessed by clicking <u>HERE</u>. Schools should only accept this most recent **KSHSAA** physical form. We encourage all schools to communicate with your local healthcare providers who administer PPEs about this version requirement.

Please remember the required PPE is only valid for the 2017-2018 school year if it is obtained on or after May 1, 2017.

The sample Parent/Student Concussion Information Release form has been updated for 2017-2018, and can be accessed by clicking <u>HERE</u>. Schools are not required to use this exact form, but are required by state law to have a new form on file each academic year signed by both a parent and the student acknowledging they have been made aware of signs, symptoms, and risks of concussions.

By making both of these forms available to you now, we hope you will provide your students with both items to be signed and returned to your office simultaneously.
