Approval of Agenda

Motion was made by Eric Ratzloff and seconded by Jamie Sowers to approve the agenda with additions as presented. Motion passed 6-0.

SPP Indicator Report FY15 - Informational

The final IDEA State Performance Plan was included in the packets. The report overall was favorable however, as in the past, the lack of community preschools was noted.

<u>Lakemary Center Contract for Student Services - Approval</u>

A student with intense needs has moved into one of our districts. This student currently attends Lakemary Center in Paola and it is recommended that the student continue with that placement. A copy of the contract for services with Lakemary was included in the packet. Dr. Mickelson noted that the parents have opted out of the ESY services offered in June and July. Motion was made by Eric Ratzloff and seconded by Todd Peterson to approve the contract for student services with Lakemary. Motion passed 6-0.

Rainwater Drainage Issues - Informational

Dr. Mickelson has visited with the property owner next door concerning rainwater drainage issues they are experiencing. Rainwater draining onto the property comes from several sources including the property owner's building and land. Installation of PVC pipe to the downspouts on the modular will extend them enough to run any of TLEC's rainwater into the ditch.

Extended School Year - Informational

The summer ESY report was distributed and reviewed with the board. Motion was made by Ryan Sink and seconded by Eric Ratzloff to approve the summer personnel as outlined. Motion passed 6-0.

Superintendent/Board Member Discussion Items

Dr. Mickelson noted that TLEC will be hosting a *Trauma Informed Care* workshop on May 23rd from 8:30 am to 3:30 pm in the Osage City School Auditorium.
