The cost responsibility of these value added beverages shall be that of the contractor and the contractor shall not charge the Sponsor for any of these costs.

This amendment is effective **July 1, 2019** and thereafter, unless otherwise amended. All other terms and conditions contained in the Contract shall remain unchanged and in full force and effect.
